THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION:

A-60 Aluminium bulkhead, SeaRox SL 620

Composed of Aluminium bulkhead insulated on both sides with minimum 2 x 30 mm mineral wool of type "SeaRox SL 620" of density 100 kg/m3 and on stiffeners side between stiffeners and upon stiffeners.

The bulkhead insulation is mounted with standard 3 mm steel pins and 38 mm steel clips (spring washers) at intervals of approx 300 / 400 mm. according to drawing.

2. DOCUMENTS AND DRAWINGS:

As per Manufacturer's drawings ALU Bulkhead A60 dated 05/03/2009

3. TEST REPORTS:

Test report N° 2009CS01950/1 dated 7 April 2009 as per FTP Code Annex 1 Part 3 [test standard : IMO Resolution A.754(18)], from RINA,Italy.

4. APPLICATION / LIMITATION:

- 4.1 The fitting aboard to be the same as used for the test.
- 4.2 The following component(s) shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:
 - the insulating material "SeaRox SL 620"
 - any added finish surface material(s).

5. PRODUCTION SURVEY REQUIREMENTS:

- 5.1 The **A-60 Aluminium bulkhead** is to be supplied by Rockwool International A/S in compliance with the type described in this certificate.
- 5.2 This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.
- 5.3 **Rockwool International A/S** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.

6. MARKING OF PRODUCT:

The product or packing is to be marked with manufacturer name, type, designation and fire-technical rating.

7. OTHERS:

- 7.1 It is **Rockwool International A/S**'s responsibility to inform shipbuilders or their sub-contractors of the proper methods of fitting, use and general maintenance of the approved equipment and the conditions of this approval.
