<u>1. PRODUCT DESCRIPTION :</u>

A-60 Aluminium deck SeaRox SL 620

Aluminium deck insulated with minimum 2 x 30 mm mineral wool of type "SeaRox SL 620" of density 100 kg/m3 between stiffeners and upon stiffeners.

The deck insulation is mounted with standard 3 mm steel pins and 38 mm steel clips (spring washers) at intervals of approx 300 / 400 mm, according to drawing.

2. DOCUMENTS AND DRAWINGS :

As per Manufacturer's drawings Deck Alu A-60 Rev and dated 17/02/2009.

3. TEST REPORTS :

Test report N° 2009CS01950/1 dated 7 April 2009 as per FTP Code Annex 1 Part 8 [test standard : IMO Resolution A.754(18)], from RINA,Italy.

4. APPLICATION / LIMITATION :

- 4.1 The fitting aboard to be the same as used for the test.
- 4.2 The following component(s) shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:
 - the insulating material(s) "SeaRox SL 620"
 - any added finish surface material(s).

5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The A-60 Aluminium deck SeaRox SL 620 is to be supplied by Rockwool International A/S in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **Rockwool International A/S** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.

6. MARKING OF PRODUCT :

The product or packing is to be marked with manufacturer name, type, designation and fire-technical rating.
