THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION :

A-60 Class Steel Deck insulated with SeaRox SL 640

Composed of steel deck insulated with 1 layer of 40 mm thick mineral wool of type SeaRox SL 640, nominal density 130 kg/m³ between and around the stiffeners.

The deck insulation is mounted with standard 3 mm steel pins and 30 mm washers welded with pitch ranging from 263 up to 400 mm.

2. DOCUMENTS AND DRAWINGS :

As per the Manufacturer's drawing 10 MJR 01 dated 11/08/2010.

3. TEST REPORTS :

Test report N°2010CS011159/2 dated 25/10/2010, as per IMO FTP Code Annex 1 Part 8 [test standard : IMO Resolution A.754(18)], from RINA, Italy.

4. APPLICATION / LIMITATION :

4.1 - The fitting aboard to be the same as used for the test.

4.2 - The following component(s) shall comply with the requirements of the relevant Bureau Veritas rules and be type approved:

- the insulating material(s) " SeaRox SL 640"
- any added finish surface material(s).

5. PRODUCTION SURVEY REQUIREMENTS :

5.1 - The A-60 Class Steel Deck is to be supplied by **Rockwool International A/S** in compliance with the type described in this certificate.

5.2 - This type of product is within the category HBV of Bureau Veritas Rule Note NR320 and as such does not require a BV product certificate.

5.3 - **Rockwool International A/S** has to make the necessary arrangements to have its works recognised by Bureau Veritas in compliance with the requirements of NR320 for HBV products.

6. MARKING OF PRODUCT :

The product or packing is to be marked with manufacturer name, type, designation and fire-technical rating.

7. OTHERS :

7.1 - It is **Rockwool International A/S's** responsibility to inform shipbuilders or their sub-contractors of the proper methods of fitting, use and general maintenance of the approved equipment and the conditions of this approval.

7.2 - This Certificate supersedes the Type Approval Certificate N°42902/A0 BV issued on 07/10/2015 by the Society.
